Booking Terms and Conditions

Orders and acceptance

- 1.1 The attendee is deemed to accept these terms and conditions (the "**Terms**") upon registering for the YST 30th Anniversary Reunion (the "**Event**") and is responsible for ensuring the accuracy of all details submitted.
- 1.2 These Terms govern the booking for, and attendance at, the Event.
- 1.3 The closing date for bookings is 17:00 on Thursday 17 April 20245, or earlier should capacity be reached.
- 1.4 Confirmation of the booking will be sent via an email after registration.

Fees

- 2.1 The prices for the YST 30th Anniversary Reunion are per person ("attendee fee") and include all refreshments, except for alcohol.
- 2.2 We will endeavour to accommodate all dietary requirements providing that the attendee provides this information within 28 days of the Event, however we are unable to guarantee this.
- 2.3 All prices include VAT at 20%, unless otherwise stated.
- 2.4 Accommodation is not included within the fee. Any accommodation must be booked independently of the Youth Sport Trust.

Payments

- 3.1 Payment in full must be received by the Youth Sport Trust prior to the date of the Event, otherwise the Youth Sport Trust reserve the right to refuse the attendee's entry into the Event.
- 3.2 All payments must be made via bank transfer, using the reference "30th Anniversary" to Youth Sport Trust: Account Number: 29788323; Sort Code: 60-14-10.

Cancellations

- 4.1 The Youth Sport Trust reserves the right to cancel or postpone the Event without notice at its discretion or due to circumstances beyond its reasonable control.
- 4.2 If the Event is cancelled a refund of the attendee fee will be issued to all attendees.
- 4.3 If the Event is postponed, attendee registrations will automatically be transferred to a revised date. For any attendees unable to attend this revised date, a refund of the attendee fee will be issued. This request for a refund must be communicated in writing to events@youthsporttrust.org.
- 4.4 In the event of cancellation by an attendee, cancellation fees will be due as follows:
 - 100% of the attendee fee will be charged for cancellations received after 17:00 on Friday 16 February 2024. Substitutions will be permitted.
- 4.5 All cancellations or substitutions must be received in writing to: events@youthsporttrust.org
- 4.6 If applicable, refunds will be paid as soon as possible, or within 30 days.

Venue

- 5.1 The Youth Sport Trust reserves the right to change the venue of the Event, if necessary. If this occurs, the Youth Sport Trust will inform attendees as soon as possible and provide information about the changes. If a change of venue occurs, the Youth Sport Trust will not be liable for any additional costs incurred by attendees.
- 5.2 Attendees must follow any health and safety requirements, including fire evacuation procedures, stipulated by the venue.
